



Committee Minutes

Chairman Young called the Economic Development, Commerce and Labor Committee to order at 2:02 pm. The Clerk called the roll and a quorum was present. Recognizing a quorum present Chairman Young asked the committee to review the minutes from the March 20th committee meeting. Without objection, the minutes were approved.

Chairman Young called 433 for its fourth hearing. Written proponent testimony was provided by Dr. Dawn Truesdale, Co-Owner of the Linworth Animal Hospital. Seeing no other witness, Chairman Young asked what was the pleasure of the committee. Vice-Chairman Reidel moved to favorably report House Bill 433 from the House Economic Development, Commerce and Labor Committee. The roll was called and HB 433 passed with 11 yea and no nay votes.

Chairman Young called HB 171 for its first hearing. The Chair called Representative Patmon to offer sponsor testimony on the bill. Questions were asked by Representatives Young, West, and Lapore-Hagan. Rep. Patmon provide an article and supporting documentation to the Chairs office for distribution to the members. With no further questions, Vice-Chairman Reidel motioned to accept a substitute bill (0823-3) as the working document for which to hear in subsequent hearings. Without objection, the substitute bill was adopted. With no further business on Substitute HB 171 to come before the committee that concluded the first hearing on the bill.

Chairman Young called HB 331 for its first hearing. Vice-Chairman Reidel made a motion to accept sub bill 1095-4 as the working document with which to work. Without objection, the substitute bill was adopted. Chairman Young called upon Representative Ingram to provide sponsor testimony on the bill. Questions were asked by Representatives Reidel, West, and Hood. Seeing no further questions, that concluded the first hearing on Substitute HB 331.

Chairman Young called HCR 24 for its second hearing. Rep. Young pointed out that written proponent testimony was provided by Bryan Williams from the Association of Builders and

Contractors. Seeing no further witnesses, that concluded the second hearing on House Concurrent Resolution 24.

As the last order of business, Chairman Young called HB 236 for its second hearing for proponent testimony. The chair recognized Vice Chairman Reidel for the purpose of a motion to accept a substitute bill (1249-2) to House Bill 236. Without objection, the substitute bill was accepted. The Chair first called upon Mr. Andrew Herf to provide proponent testimony on Sub HB 236. Several questions were asked by Representatives Lapore-Hagan, Reidel, Hood, and Young. Next, Chairman Young called upon Norm Martin, Codes and Standards office for Schindler Elevator to testify. Questions here asked by Representatives Lapore-Hagan, Sheehy, Reidel, Young and West. With no further questions, Chairman Young called upon Kevin Sullivan, National Coordinator for EIWPF to provide proponent testimony. Chairman Young asked several questions. Lastly, Chairman Young called upon Phillip Isaac to provide testimony. With no questions of the witness, Chairman Young noted that written testimony was also provided by Dylan Isenberg, Director of national Elevator Industry, Inc.

Seeing no further business to come before the committee and having concluded the business of the day, the House Economic Development, Commerce and Labor Committee was adjourned at 3:23 PM.
