OCCUPATIONAL LICENSING BOARDS AND LICENSES SUBJECT TO SUNSET REVIEW UNDER S.B. 255 OF THE 132ND GENERAL ASSEMBLY, AS INTRODUCED

SUMMARY

This memorandum lists every occupational licensing board that would be subject to sunset review under S.B. 255 of the 132nd General Assembly, As Introduced, and each type of license that each board may issue.

With respect to the types of licenses, this memorandum addresses (1) licenses issued to individuals, and (2) licenses that could be issued to an individual or a business entity. It does not address licenses that are issued only to a business entity. Additionally, it does not discuss driver licenses, liquor permits, building permits, or other licenses that are not necessary for an individual to perform a task related to a profession or occupation.

As used in the bill and in this memorandum, "occupational licensing board" means a board, commission, committee, or council, or any other similar state public body, and any administrative department enumerated under R.C. 121.02, and any agency, division, or office of state government, that issues an occupational license. "Occupational license" means nontransferable authorization in law that an individual must possess in order to perform a lawful occupation for compensation based on meeting personal qualifications established by statute or by rule authorized by statute.
