**HIGHLAND LOCAL SCHOOL DISTRICT  
BOARD OF EDUCATION  
RESOLUTION IN SUPPORT OF HOUSE BILL 8**

WHEREAS, under continuing Public Records Law, any person may request to inspect or obtain copies of public records from a public office unless part or all of a record is exempt from release; and

WHEREAS, under continuing Public Records Law, traffic accident reports are not exempt from release; and

WHEREAS, traffic accident reports involving school vehicles may contain the name, address, contact information, and other personal information of a person who is under the age of 18; and

WHEREAS, the Highland Local School District Board of Education desires to protect the privacy of minors; and

WHEREAS, the Ohio House of Representatives is currently considering legislation that would amend 149.43 of the Revised Code to exempt from the Public Records Law certain information concerning a minor that is included in a record related to a traffic accident involving a school vehicle in which the minor was an occupant at the time of the accident;

NOW THEREFORE BE IT RESOLVED, that the Highland Local School District Board of Education does hereby express its strong support of the proposed legislation, House Bill 8; and

BE IT FURTHER RESOLVED that the Treasurer be directed to forward copies of the resolution to members of the Ohio House of Representatives.
