House Public Utilities Committee Written Testimony on House Bill 114 March 21, 2017

Dear Chairman Seitz and Members of the House Public Utilities Committee:

We are concerned with the unprecedented pace at which the House Public Utilities Committee is pushing forward on HB 114 and issue the following statement to make clear that we staunchly oppose HB 114.

Major Ohio businesses and manufacturers are saving money as a result of Ohio's alternative energy and energy efficiency standards (S.B. 221).

HB114 would make Ohio's renewable standards voluntary, weaken energy efficiency standards and allow commercial and industrial customers who use more than 700,000 kWH per year to opt out of energy saving programs. These changes would have a devastating impact on the clean energy economy in Ohio.

Ohio's clean energy standards enjoy significant support from the business community.

During the 2016 legislative session, nine major businesses that collectively employ over 25,000 Ohioans, called on lawmakers to reinstate Ohio's successful clean energy standards and oppose HB 554. These companies—Nestle, Whirlpool, Owens Corning and others—support clean energy standards because they help businesses cut energy costs, avoid the volatility of fossil fuel prices, and help companies stay competitive. When Governor Kasich vetoed HB 554, he sent a clear market signal that clean energy jobs, investment and innovation are welcome in Ohio. HB 114 puts Ohio's reputation at risk, again.

HB 114 is a step in the wrong direction.

HB114 will remove the accountability for utilities to invest in energy solutions that save ratepayers money. Lawmakers should encourage energy solutions that work. HB 114 will only serve to stall investments and create prolonged uncertainty for businesses and investors in Ohio.

Ohio stands to lose significant investment and job growth if this bill becomes law.

Ohio's clean energy standards have resulted in thousands of new jobs and stimulated over \$160 million in annual GDP growth. Ratepayers are saving hundreds of millions of dollars each year on their utility bills, and are on track to save over \$5 billion by 2020.

As you consider this legislation, we hope you heed the recommendations of the business community and protect Ohio's clean energy economy.
