Representative Celebrezze reported for the Rules and Reference committee recommending that the following House Bills be considered for the second time and referred to the following committees for consideration:

H. B. No. 481 – Representatives Greenspan, Fedor

To create the "Stop Bullying" license plate.

To the committee on Transportation and Public Safety

H. B. No. 482 – Representatives Lipps, Miller

To expedite public nuisance and blight foreclosure actions and to declare an emergency.

To the committee on Civil Justice

H. B. No. 483 – Representative Patterson

To designate the second week of October as "Ohio Covered Bridge Week."

To the committee on State and Local Government

H. B. No. 484 – Representative Brenner

To authorize city and general health districts to use credit cards in accordance with prescribed requirements.

H. B. No. 485 – Representative Antani

To enact "Cody's Law" to designate January 30 as "Chronic Traumatic Encephalopathy Awareness Day."

H. B. No. 486 – Representative Antonio

To specify that emergency medical service workers are public safety officers under the Ohio Public Employees Retirement System.

H. B. No. 487 – Representative Ingram


To eliminate the right of first refusal for community schools, college-preparatory boarding schools, and science, technology, engineering, and mathematics schools in the acquisition of school district real property.

To modify the information conveyed in election notices and ballot language for property tax levies.

H. B. No. 489 – Representative Dever

To provide some regulatory and tax relief to state banks and credit unions, to provide for data analytics to be conducted on publicly available information regarding banks, credit unions, and consumer finance companies, to modify when a creditor can file a claim against an estate, to require registration of mortgage loan servicers, and to require a specified notice be given to a debtor for certain debt collection.

To exempt certain residential buildings from agricultural labor camp licensing.

H. B. No. 491 – Representative Edwards

To require the State Board of Education to issue a substitute license to specified pupil services personnel.

To establish the women-owned business enterprise program requiring state agencies to establish women-owned business procurement goals.

To authorize the Director of Administrative Services to enter into reciprocal agreements with other states with respect to the certification of minority business enterprises and EDGE business enterprises.

To specify that a franchisor is not the employer of a franchisee or employee of a franchisee for purposes of the Minimum Fair Wage Standards Law, the Bimonthly Pay Law, the Workers' Compensation Law, the Unemployment Compensation Law, and the Income Tax Law.
