A BILL

To amend sections 3717.33 and 3717.52 of the 1
Revised Code to require the Director of 2
Agriculture and the Director of Health to adopt 3
rules governing the assessment of registered 4
sanitarians and sanitarians-in-training who 5
conduct inspections of retail food 6
establishments and food service operations. 7

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That sections 3717.33 and 3717.52 of the 8
Revised Code be amended to read as follows: 9

Sec. 3717.33. Pursuant to section 3717.04 of the Revised 10
Code, the director of agriculture shall adopt rules regarding 11
the following: 12

(A) Licensing categories for retail food establishments 13
and licensing requirements for each category, including 14
appropriate practices for the activities performed by a retail 15
food establishment; 16

(B) Standards for collection of food samples from retail 17
food establishments for purposes of identifying adulteration and 18

(C) Records to be generated and maintained by licensed retail food establishments;	20 21
(D) Appeals of proposed suspensions and revocations of retail food establishment licenses and appeals of suspensions of licenses issued for violations presenting a clear and present danger to the public health;	22 23 24 25
(E) Standards and procedures, including a schedule of frequency, for conducting inspections of retail food establishments;	26 27 28
(F) Standards and procedures for determining during an inspection whether articles should be removed from use because of a clear and present danger to the public health;	29 30 31
(G) Standards and procedures for conducting investigations of complaints pertaining to retail food establishments;	32 33
(H) Surveys conducted by the director to determine whether boards of health are qualified and have the capacity to administer and enforce the provisions of this chapter and the rules adopted under it applicable to retail food establishments and to abide by the Ohio uniform food safety code r . <u>The rules shall require, as part of a survey, both of the following:</u>	34 35 36 37 38 39
<u>(1) The director to evaluate whether an individual registered as a sanitarian or sanitarian-in-training under Chapter 4736. of the Revised Code who is employed by or has contracted with a board of health to enforce this chapter as it relates to retail food establishments has sufficient knowledge of the provisions of this chapter, rules adopted under it, and of the Ohio uniform food safety code to conduct such enforcement;</u>	40 41 42 43 44 45 46 47

(2) The director to evaluate an individual under division 48
(H) (1) of this section solely through the use of an objective 49
written or electronic assessment that complies with all of the 50
following: 51

(a) It is developed by the director and representatives 52
from the Ohio environmental health association and the 53
association of Ohio health commissioners. 54

(b) It does not exceed fifty questions in length. 55

(c) In order to pass the assessment, the individual must 56
correctly answer eighty per cent or more of the questions in the 57
assessment. 58

(d) The individual is allowed to review the Ohio uniform 59
food safety code during the assessment. 60

(I) Reinstatement of a board of health as a licenser after 61
the director has revoked the approval of the board; 62

(J) Procedures for resolving disputes between licensers 63
and the holders of licenses for retail food establishments; 64

(K) Procedures for providing enforcement support to a 65
board of health requesting assistance in the prosecution of a 66
person for a violation of the provisions of this chapter 67
applicable to retail food establishments; 68

(L) Any other matter the director considers relevant to 69
the administration and enforcement of the provisions of this 70
chapter applicable to retail food establishments. 71

Sec. 3717.52. Pursuant to section 3717.04 of the Revised 72
Code, the director of health shall adopt rules establishing 73
procedures for the following: 74

(A) Appeals of proposed suspension or revocation of food 75
service operation licenses and appeals of suspension of licenses 76
issued for violations presenting immediate danger to the public 77
health; 78

(B) Surveys conducted by the director to determine whether 79
boards of health are qualified and have the capacity to 80
administer and enforce the provisions of this chapter and the 81
rules adopted under it applicable to food service operations and 82
to abide by the Ohio uniform food safety code~~r~~. The rules shall 83
require, as part of a survey, both of the following: 84

(1) The director to evaluate whether an individual 85
registered as a sanitarian or sanitarian-in-training under 86
Chapter 4736. of the Revised Code who is employed by or has 87
contracted with a board of health to enforce this chapter as it 88
relates to food service operations has sufficient knowledge of 89
