

## House Transportation and Public Safety Committee

### Minutes

May 24, 2017

Chairman Green called the meeting of the House Transportation and Public Safety Committee to order with prayer at 9:00 am in Statehouse Room 017. Attendance was taken and a quorum was present. The minutes from May 17, 2017 were approved without objection.

Chairman Green called up House Bill 190 for its first hearing.

- Chairman Green recognized Reps. Lepore-Hagan & Schuring to provide sponsor testimony of House Bill 190. Reps. Lepore-Hagan & Schuring answered the questions of the committee.

Chairman Green called up House Bill 212 for its first hearing.

- Chairman Green recognized Rep. Householder to provide sponsor testimony of House Bill 212.
- Chairman Green recognized Mr. John Lawrence to provide proponent testimony of House Bill 212. Mr. Lawrence answered the questions of the committee.
- Vice Chairman Greenspan moved to report favorably House Bill 212. The bill was reported favorably by a vote of 13-0. At the Chair's discretion the roll was left open in the clerk's office until 10:00 am the next day.

Chairman Green called up House Bill 159 for its second hearing.

- Chairman Green recognized Ms. Donna Grube to provide proponent testimony of House Bill 159. Ms. Grube answered the questions of the committee.
- Chairman Green noted that approximately a dozen organizations submitted letters of support for House Bill 159.
- Vice Chairman Greenspan moved to report favorably House Bill 159. The bill was reported favorably by a vote of 15-0.

Chairman Green called up House Bill 194 for its second hearing.

- Chairman Green recognized Mr. Malcolm Glasgow to provide proponent testimony of House Bill 194.
- Chairman Green noted that AMVETS Department of Ohio submitted a letter of support for House Bill 194.
- Vice Chairman Greenspan moved to report favorably House Bill 194. The bill was reported favorably by a vote of 15-0.

Chairman Green called up House Bill 195 for its second hearing.

- Vice Chairman Greenspan moved to amend House Bill 195 with AM 0226. The amendment was explained. The motion was approved without objection and AM 0226 became a part of the bill.

- Chairman Green recognized Mr. Kevin Flynn to provide proponent testimony of House Bill 195. Mr. Flynn answered the questions of the committee.
- Vice Chairman Greenspan moved to report favorably House Bill 195. The bill was reported favorably by a vote of 13-0. At the Chair's discretion the roll was left open in the clerk's office until 10:00 am the next day.

Chairman Green called up House Bill 206 for its first hearing.

- Chairman Green recognized Rep. Barnes to provide sponsor testimony of House Bill 206. Rep. Barnes answered the questions of the committee.
