Senator Coley made a motion for favorable passage of Sub. SB70, Senator Dolan seconded the motion.  
OUTCOME: Sub. SB 70 passed the Senate Judiciary Committee by a vote of 10 to 0.

OUTCOME: Sub. HB63 favorably passed the Senate Judiciary Committee with a vote of 9 to 1
