71 **Temporary occupational license for military member and**  
72 **spouse**

73 **R.C. 4743.04 and 4743.041 (primary); R.C. 4730.121,**  
74 **4731.153, 4731.299, 4731.57, 4734.281, 4734.285, 4734.49,**  
75 **4759.02, 4759.064, 4759.10, 4760.041, 4761.03, 4761.052,**  
76 **4762.03, 4762.041, 4774.041, 4778.051, 4778.07, 4778.08,**  
77 **4778.081, and 5903.04**

78 Removes provisions added in the Senate version that do all  
79 of the following:

80 Requires state occupational licensing agencies, under  
81 certain circumstances, to issue temporary licenses or  
82 certificates to members of the military and spouses who are  
83 licensed in another jurisdiction and have moved or will move to  
84 Ohio for duty, waive all fees associated with issuing these  
85 temporary licenses or certificates, and issue the temporary  
86 license or certificate for a duration of not more than six  
87 years.

88 Allows a state licensing agency to deny or revoke a  
89 temporary license or certificate issued under the bill under  
90 certain circumstances.

91           Requires the Director of Administrative Services to prepare  
92 a report for each fiscal year on the number and type of  
93 temporary licenses or certificates issued during the fiscal year  
94 and provide the report to the Director of Veterans Services to  
95 make the report available to the public.

96           Excludes the State Medical Board from the temporary license  
97 or certificate requirements and instead requires the Board,  
98 under certain circumstances, to issue expedited licenses by  
99 endorsement to members of the military and spouses who are  
100 licensed in another jurisdiction and have moved or will move to  
101 Ohio for duty.

102           Requires the Board to waive the current law application fee  
103 for certain members of the military and spouses who apply for an  
104 expedited license to practice medicine and surgery or  
105 osteopathic medicine and surgery by endorsement.
