A BILL

To enact sections 103.60 and 3701.051 of the 1
Revised Code to establish the Rare Disease 2
Advisory Council. 3

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That sections 103.60 and 3701.051 of the 4
Revised Code be enacted to read as follows: 5

Sec. 103.60. (A) As used in this section, "rare disease" 6
means a disease or condition that affects fewer than 200,000 7
people living in the United States. 8

(B) There is hereby created the rare disease advisory 9
council. The purpose of the council is to advise the general 10
assembly regarding research, diagnosis, and treatment efforts 11
related to rare diseases across the state. 12

(C) The council shall consist of the following twenty-four 13
members: 14

(1) The following members appointed by the governor: 15

- (a) One individual who is a medical researcher with experience researching rare diseases; 16

- (b) One individual who represents an academic research institution in this state that receives funding for rare disease research; 18

- (c) One individual authorized under Chapter 4731. of the Revised Code to practice medicine and surgery or osteopathic medicine and surgery who has experience researching, diagnosing, and treating rare diseases; 21

- (d) One individual authorized under Chapter 4723. of the Revised Code to practice nursing as a registered nurse who has experience providing nursing care to patients with rare diseases; 25

- (e) One individual authorized under Chapter 4778. of the Revised Code to practice as a genetic counselor who is currently practicing at a children's hospital; 29

- (f) Three members of the public who are living with a rare disease or represent an individual living with a rare disease; 32

- (g) One representative of the national organization for rare disorders; 34

- (h) One representative of a rare disease foundation operating in this state; 36

- (i) Two representatives of the department of health, one of whom is a representative of the children with medical handicaps program; 38

- (j) One representative of the department of medicaid; 41
