Dear Chair Manning:

We write this letter to express of our opposition to Ohio House Bill 219.

Today- Ohio residents are given the opportunity to decide if beer, wine and spirits are to be sold in their local community. The Ohio Division of Liquor together with local boards of elections let Ohio residents through a series ballot options decide if any alcohol is to be sold- and if so- then they determine what types of alcohol and on what days of the week it will be sold. The ballot option system lets Ohio residents decide what is best for their local neighborhood. House Bill 219 would eliminate a Sunday-sales liquor distinction that is currently determined using the ballot option. HB 219 would in an instant give Sunday liquor sales to thousands of businesses- who have not earned that distinction through the ballot option. HB 219 would strip the decision away from local residents and the communities in which they live.

We believe we have been a reliable and responsible partner with the Division of Liquor. Discount Drug Mart has worked closely with the Division over our 50 years as a company to make sure we are adhering to the established rules and regulations- we have played by the rules. HB 219 would change the rules- and would hurt Ohio companies including our own. Discount Drug Mart has 75 locations in Ohio- our stores are only in Ohio. For each of our stores- we have established Sunday sales by working with the Division of Liquor and local boards of elections to ask local residents for their approval.

Eliminating the Sunday-sales liquor ballot option would only harm Ohio companies like ours. Most Ohio companies (e.g. Kroger, Marc's, Heinen's & Buehler's) like Discount Drug Mart have gained Sunday sales through the ballot option- while most of the out-of-state companies have

not gained Sunday sales through the ballot option. Dollar General (based in Goodlettsville, Tennessee) has 361 locations in Ohio. **Of the 361 Dollar General locations in Ohio- only 2 locations have Sunday sales.** If HB 219 passes- the other 359 Dollar General locations without Sunday sales will suddenly have that privilege. More than 60% of the Walgreens stores (based in Deerfield, Illinois) and CVS stores (based in Woonsocket, Rhode Island) **do not** have Sunday sales. By comparison- 100% of Discount Drug Mart locations have Sunday sales.

We believe HB 219 is an **affront to Ohio residents that will take away their right** to determine what is best for their neighborhoods and communities. We believe HB 219 is an attack on Ohio's companies and their employees. Eliminating the Sunday sales distinction would take away from Ohio companies an earned competitive advantage. The passage of **HB 219 would merely give** the Sunday sales distinction to everyone.
