

HB 253 – Proponent Testimony 12/10/2019

On behalf of the Ohio Pyrotechnic Arts Guild (OPAG)

Chairman Manning, Vice-Chairman Dean, Ranking Member Lepore-Hagan, and members of the committee, I am Bruce Blom, co-founder and past president of the Ohio Pyrotechnic Arts Guild – OPAG and currently serve as the Vice President-Communications, for the Pyrotechnics Guild International – PGI. Thank you for the opportunity today to testify in support of House Bill 253.

OPAG is an educational and fraternal association of Ohio licensed exhibitors and licensed assistants, founded in 1997. I've attached a copy of the goals of OPAG, and in reading those, you can understand why we support efforts to revisit and hopefully modernize current Ohio law regarding fireworks.

This committee will hear much testimony, pro and con, focused on the sale to, and use by the general public, of 1.4g (consumer) fireworks. While we are supportive of wider sale and use of 1.4g fireworks, we wish to emphasize that we are not in the business of selling 1.4g or 1.3g (display) fireworks. We are user of these products in that we provide our expertise to licensed firms to conduct displays on their behalf. We also purchase these products from Ohio-licensed sources for use at our Guild events.

However, there are many other parts to current law that need to be addressed, particularly concerning storage and manufacturing. The current moratorium that has shackled this industry for 20+ years is a significant roadblock to free trade, competition and product development, all to the detriment of consumers and other interested parties. Now, thanks to Representatives Manning and O'Brien, and the support of Representatives Seitz and Lipps, we stand on the cusp of ending the egregious practices fostered by the current law. OPAG remains optimistic that, if passed, the proposed Study Group will see the merits in evaluating and adopting the practices of our neighboring states and less on home-grown regulatory overkill.
