"Sec. 5534.896. The bridge that is part of state route 26
number six hundred three, located in the village of Plymouth in 27
Huron and Richland counties, and being a part of the road known 28
as Trux street, shall be known as the "Trucks Bridge." 29

"Sec. 5534.913. In addition to any other name prescribed 33
in the Revised Code or otherwise, the northbound and southbound 34

South Woodland road and Harvard road, in Cuyahoga county, shall 36
be known as the "Ronald H. Barron Memorial Highway." 37
