Chairman Oelslager called up House Bill 388 for its eighth hearing.

Representative Butler moved to accept a substitute bill (133_1962-15). Chairman Callender seconded the motion. The motion was approved without objection.

Representative Butler explained the substitute bill and answered questions from the committee members.

Chairman Oelslager called up House Bill 13 for its fourth hearing.

Representative Carfagna moved to accept a substitute bill (133_0236-3). Representative Greenspan seconded the motion. The motion was approved without objection.

Representative Carfagna and Representative O'Brien explained the changes in the substitute bill and answered questions of the committee members.

Chairman Oelslager called up Senate Bill 310 for its second hearing.

Jason Warner of the Greater Ohio Policy Center was present and gave proponent testimony. Mr. Warner answered questions asked by the committee members.

There was written only testimony from Dan Langshaw of the City of North Royalton and the local government associations: CCAO, OML, OTA, Ohio Mayors Alliance, Northeast Ohio Mayors and City Managers Association, and the Cuyahoga County Mayors and City Managers Association.
