Repeal of obsolete sections	
Repeals sections that are obsolete by their own terms, because they either prevent the discontinuance of a contract prior to a specific date that has since passed or because they appear to apply to contracts that are no longer in existence (<i>R.C. 3941.47, 3941.48, 3941.49, and 3941.52, with a conforming change in R.C. 3923.39</i>).	No provision.
Corrective intent	
No provision.	States that, except for the following amendments that were included in the As Introduced version of the bill, the bill is intended to correct nonsubstantive errors only:

An amendment that provides that a regional council of governments established to provide health care benefits to the council members' officers and employees and their dependents that provides such benefits through a nonprofit self-funded program is not subject to the Ohio insurance laws so long as the council does not act as a third-party administrator. 2. An amendment extending the length of time by which a life insurance policy may be backdated from three to six months. <i>(R.C. 1.301, 1.67, and 3915.13.)</i>
