Re: House Concurrent Resolution 12 – Illegal Robocalls

Dear Chairman Callender, Vice Chairman Wilkin, Ranking Member Smith, and Members of the House Public Utilities Committee:

As leading providers of voice services, members of the Ohio Cable Telecommunications Association (OCTA) have been at the forefront of industry efforts to protect consumers from illegal robocalls. In many cases, OCTA members have voluntarily implemented measures to combat this difficult problem, while also supporting efforts by the Federal Communications Commission (FCC) and Congress to stem the tide of these calls. For example, two OCTA members recently partnered with Attorneys General from across the country, including Ohio, and voluntarily agreed to abide by strong anti-robocalling principles. We are pleased, therefore, that the Ohio General Assembly wishes to motivate federal action and we respectfully encourage you to support House Concurrent Resolution 12 (HCR 12).

With the FCC and Congress both considering further action to combat illegal robocalls, HCR 12 is both timely and relevant. As you may know, in June 2019, the FCC expanded call blocking to protect consumers from unlawful and unwanted calls and sought comment on whether to mandate caller ID authentication. Additionally, both the US House and US Senate have passed anti-robocall bills and just agreed in principle on the text of new legislation that would require caller ID authentication, allow call blocking, and strengthen FCC enforcement.

We strongly believe federal action represents the best approach to combat illegal robocalls and protect consumers in a consistent manner. Support from Ohio urging federal action could help get federal legislation passed, while also ensuring that the many voice providers with customers in multiple states have just one set of rules with which they must comply.
