Chair Wiggam called the meeting to order at 3:02 PM. A quorum was present.

Chair Wiggam asked the members to review the minutes from Wednesday, June 19, 2019, without objection, the minutes were approved.

The Chair announced that HB 36 would be receiving its Third Hearing for All Testimony. Vice-Chairman Ginter motioned to favorably report HB 36 from the State and Local Government Committee. With a vote of 14 yeas, 0 nays, and 1 excused the bill will be favorably reported out of committee.

The Chair announced that HB 117 would be receiving its Third Hearing for All Testimony. Representative Skindell motioned to favorably report HB 117 from the State and Local Government Committee. With a vote of 14 yeas, 0 nays, and 1 excused the bill will be favorably reported out of committee.

Written proponent testimony for HB 117 was provided by Bob DiBiasio, Senior VP of Public Affairs for the Cleveland Indians.

The Chair announced that SB 123 would be receiving its Second Hearing for All Testimony. Vice-Chairman Ginter motioned to favorably report SB 123 from the State and Local Government Committee. With a vote of 14 yeas, 0 nays, and 1 excused the bill will be favorably reported out of committee.

Chairman Wiggam announced that HB 20 would be receiving its First Hearing for Sponsor Testimony. Representative Blessing provided sponsor testimony. Questions were asked by Representatives Russo, Strahorn, Becker, Arndt, Skindell, Ginter, Smith (Ryan), Sobecki, and Hambley to Representative Blessing.

The Chair announced that HB 242 would be receiving its Fourth Hearing for All Testimony. Vice-Chairman Ginter motioned to favorably report HB 242 from the State and Local Government Committee. With a vote of 8 yeas, 6 nays, and 1 excused the bill will be favorably reported out of committee.

Written opponent testimony for HB 242 was provided by Crystal Davis, Policy Director for the Alliance for the Great Lakes; Holly Parker Curry, Florida Regional Manager of the Surfrider Foundation; and Diane Bickett, Executive Director of the Cuyahoga County Solid Waste District.

Chairman Wiggam announced that HB 138 would be receiving its Second Hearing for Proponent Testimony. Written proponent testimony for HB 138 was submitted by Kent Scarrett, Executive Director of the Ohio Municipal League and Anthony Zampedro, Acting City Manager of the City of Mentor.

The Chair announced that per ORC 101.63, the State and Local Government Committee will now review Occupational Licensing Boards. The first boards the committee will be reviewing are the Historical Boiler Licensing Board and the Ski Tramway Board. The committee also heard from the Common Sense Initiative.

From the Historical Boilers Licensing Board, Aaron Johnston from the Department of Commerce provided testimony. Questions were asked to the witness by Representatives Skindell, Hambley, Kelly, Ginter, and Wiggam.

From the Ski Tramway Board, Aaron Johnston from the Department of Commerce provided testimony. Questions were asked to the witness by Representative Wiggam.

From the Common Sense Initiative, Carrie Kuruc, Director of the Common Sense Initiative provided testimony.
