may apply to the registrar for the registration of the vehicle 17
and issuance of "Summit Metro Parks" license plates. The 18
application may be combined with a request for a special 19
reserved license plate under section 4503.40 or 4503.42 of the 20
Revised Code. Upon receipt of the completed application and 21
compliance by the applicant with divisions (B) and (C) of this 22
section, the registrar shall issue to the applicant the 23
appropriate vehicle registration and a set of "Summit Metro 24
Parks" license plates and a validation sticker, or a validation 25
sticker alone when required by section 4503.191 of the Revised 26
Code. 27

In addition to the letters and numbers ordinarily 28
inscribed on the license plates, "Summit Metro Parks" license 29
plates shall display an appropriate logo and words that are 30
selected by representatives of the Summit metro parks foundation 31
and approved by the registrar. "Summit Metro Parks" license 32
plates shall display county identification stickers that 33
identify the county of registration as required under section 34
4503.19 of the Revised Code. 35

(B) "Summit Metro Parks" license plates and a validation 36
sticker, or validation sticker alone, shall be issued upon 37
receipt of an application for registration of a motor vehicle 38
under this section; payment of the regular license tax as 39
prescribed under section 4503.04 of the Revised Code, any 40
applicable motor vehicle license tax levied under Chapter 4504. 41
of the Revised Code, any applicable additional fee prescribed by 42
section 4503.40 or 4503.42 of the Revised Code, an additional 43
administrative fee of ten dollars, and a contribution as 44
provided in division (C)(1) of this section; and compliance with 45
all other applicable laws relating to the registration of motor 46
vehicles. 47

(C) (1) For each application for registration and 48
registration renewal notice the registrar receives under this 49
section, the registrar shall collect a contribution of ten 50
dollars. The registrar shall deposit this contribution into the 51
state treasury to the credit of the license plate contribution 52
fund created in section 4501.21 of the Revised Code. 53

(2) The registrar shall deposit the administrative fee of 54
ten dollars, the purpose of which is to compensate the bureau of 55
motor vehicles for additional services required in the issuing 56
of "Summit Metro Parks" license plates, into the state treasury 57
to the credit of the public safety - highway purposes fund 58
created in section 4501.06 of the Revised Code." 59
