

**OHIO SENATE**  
**Committee on Finance Minutes**  
**June 19, 2019**  
**133rd General Assembly**

The Senate Committee on Finance was called to order pursuant to the meeting notice at approximately 7:10 pm in the Finance Hearing Room of the Statehouse.

Attendance was taken. A quorum was present.

The minutes of the June 17, 2019 committee meeting were approved.

The Chair called H. B. 166 for its twelfth hearing.

The following amendments were offered:

Chairman Dolan moved to amend with SC5585 (Senate Omnibus Amendment to HB 166). Senator Burke seconded the motion. The motion was agreed to without objection.

Senator Antonio moved to amend with SC5247x1 (Service entities and naloxone). Senator Sykes seconded the motion. The motion was agreed to without objection.

Senator Sykes moved to amend with SC4736x1 (Department of Education - Career-Technical Education Enhancements). Senator Antonio seconded the motion. The motion was agreed to without objection.

Senator Antonio moved to amend with SC5206 (Department of Jobs and Family Services - Adult Protective Services). Senator Sykes seconded the motion. Senator Burke moved to table the amendment. The motion was seconded by Senator Terhar. The motion to table was agreed to by a vote of 10-3.

Senator O'Brien moved to amend SC5403 (Development Services Agency and Census 2020 Complete Count Commission). Senator Antonio seconded the motion. Senator Burke moved to table the amendment. The motion was seconded by Senator Terhar. The motion to table was agreed to by a vote of 8-5.

Senator Sykes moved to amend with SC5595 (SC4931 - Educational Choice Scholarship Program - limit on number of scholarships, SC4932 - Ed Choice scholarship eligibility, SC4936 - Ed Choice Scholarship computations, SC4937 - Ed Choice scholarship application periods - remove changes). Senator O'Brien seconded the motion. Senator Burke moved to table the amendment. The motion was seconded by Senator Eklund. The motion to table was agreed to by a vote of 8-5.

Senator Antonio moved to amend with SC5592 (Earned income tax credit refundability and Business income deduction). Senator O'Brien seconded the motion. Senator Burke moved to table the amendment. The motion was seconded by Senator Terhar. The motion to table was agreed to by a vote of 10-3.

Senator Skyes moved to amend with SC5269 (Development Services Agency - Euclid Shore Cultural Center window replacement). Senator Antonio seconded the motion. The motion was agreed to without objection

Senator Burke moved that H. B. 166 be favorably reported to the Committee on Rules and Reference. Senator Sykes seconded the motion. The motion was agreed to by a vote of 13-0.

Senator Burke moved to harmonize the bill. Senator Eklund seconded the motion.
