Chairperson Dolan and Esteemed Senate Finance Committee Members,

I am Shyam Suchak and writing to provide testimony on behalf of Anne Grady Services where I serve as the Director of Operations. We are an agency that serves children and adults who have intellectual disabilities. We provide ICF and Waiver setting residential services, day programming, respite care, and transportation services in Northwest Ohio. We serve over 150 residentially and over that number in day programming. We also serve around 500 people in transportation. We provide services in two counties and have approximately 400 employees.

I want to express my deepest gratitude to Governor DeWine, Director Davis, the Ohio Department of Developmental Disabilities, and the Ohio House of Representatives who, separately and collectively, have made an unprecedented investment in services for individuals with intellectual and developmental disabilities. I am appreciative of the administration and the Ohio House's proposal to invest in the homemaker/personal care service to help increase the average wage of DSPs providing that service. This will help recruit and retain our DSPs who provide these services. It will help our staff who currently need to work many additional hours (overtime) to obtain a paycheck to help them with living expenses. In turn, this will help the individuals we serve. If staff are working too many hours because they need the money or we are short-staffed, they can become burned out. Higher wages and working fewer hours can help decrease burnout and is a clear benefit to the people we serve.

Finally, a reduction in the number of quality indicators will help us reduce unnecessary documentation, free up staff time, and allow us to provide better care.

The developmental disabilities services field is in agreement on the direction and actions to be taken to increase our support and positive outcomes for individuals with disabilities and their valued DSPs. On behalf of my agency, my staff, and the individuals we support, I encourage you, Senator Dolan and Members of this Committee, to support the proposed budget provisions relevant to the Department of Developmental Disabilities. Together we will succeed.
