

OHIO SENATE
Committee on Health, Human Services and Medicaid Minutes
March 12, 2019
133rd General Assembly

The Senate Committee on Health, Human Services, and Medicaid was called to order pursuant to the meeting notice at approximately 4:13 p.m. in the South Hearing Room of the Statehouse.
