

OHIO SENATE
Committee on Health, Human Services and Medicaid Minutes
September 1, 2020
133rd General Assembly

The Senate Committee on Health Human Services and Medicaid was called to order pursuant to the meeting notice at approximately 4:05pm in the South Hearing Room of the Statehouse.

Attendance was taken with a quorum present. The Committee proceeded to its first order of business.

The chair called up Senate Bill 348 (Schaffer, Roegner) for its first hearing. The following testimony was provided:
