

**OHIO SENATE**  
**Committee on Rules and Reference Minutes**  
**February 26, 2020**  
**133rd General Assembly**

Chairman Obhof called the meeting to order.  
Attendance was taken. A quorum was present.

The Chair called for a motion to accept the minutes of the previous meeting. Senator Dolan moved that the minutes of the previous meeting be accepted without changes or corrections. Senator O'Brien seconded the motion. Hearing no objections, the minutes were accepted as written.

The first order of business was reports to committees of appointments by the Governor: Agriculture and Natural Resources - Finance - Insurance and Financial Institution - Local Government, Public Safety and Veterans Affairs - Transportation, Commerce and Workforce. All the reports were properly signed.

The second order of business was the Advise and Consent report of appointments by the Governor. Senator Thomas moved that the report be referred to the floor. Senator Eklund seconded the motion. The report was referred to the floor by a vote of 13-0 and the report was properly signed.

The third order of business was the Reference Report for Wednesday, February 26, 2020. Senator Kunze moved that the report be referred to the floor. Senator Wilson seconded the motion. The report was referred to the floor by a vote of 13-0 and the report was properly signed.

The fourth order of business was the calendar for Wednesday, February 26, 2020:

The Chair called up S.C.R. No. 8 (Roegner/Peterson) Urge Congress-permanently extend Daylight Saving Time.

Senator Peterson moved S.C.R. No. 8, seconded by Senator Thomas. S.C.R. No. 8 was referred to the floor by a vote of 13-0.

The Chair called up S.B. No. 73 (Brenner) Alter law governing yielding to pedestrians in crosswalks.

Senator O'Brien moved S.B. No. 73, seconded by Senator Wilson. S.B. No. 73 was referred to the floor by a vote of 13-0.

The Chair called up S.B. No. 125 (Hottinger/Brenner) Expand tax deduction for 529 education savings plan.

Senator Burke moved S.B. No. 125, seconded by Senator O'Brien. S.B. No. 125 was referred to the floor by a vote of 13-0.

The Chair called up S.B. No. 158 (Kunze) Create Ohio Bullfrog license plate.

Senator O'Brien moved S.B. No. 158, seconded by Chairman Obhof. S.B. No. 158 was referred to the floor by a vote of 13-0.

The Chair called up S.B. No. 230 (Craig/Antonio) Designate Diabetic Ketoacidosis (DKA) Day.

Senator O'Brien moved S.B. No. 230, seconded by Senator Yuko. S.B. No. 230 was referred to the floor by a vote of 13-0.

There being no further business to come before the committee, Senator Coley moved that the meeting be adjourned. Senator O'Brien seconded the motion.
