

OHIO SENATE
Committee on Rules and Reference Minutes
June 3, 2020
133rd General Assembly

Chairman Obhof called the meeting to order.
Attendance was taken. A quorum was present.

The Chair called for a motion to accept the minutes of the previous meeting. Senator Burke moved that the minutes be accepted without changes or corrections. Senator Eklund seconded the motion. Hearing no objections, the minutes were accepted as written.

The first order of business was the Advise and Consent report of appointments by the Governor. Senator Wilson moved that the report be referred to the floor. Senator Yuko seconded the motion. The report was referred to the floor by a vote of 13-0 and the report was properly signed.

The second order of business was the Reference Report for Wednesday, June 3, 2020. Senator O'Brien moved that the report be referred to the floor. Senator Peterson seconded the motion. The report was referred to the floor by a vote of 13-0 and the report was properly signed.

The third order of business was the calendar for Wednesday, June 3, 2020:

The Chair called up S.C.R. No. 13 (Johnson) Require branches of government conform to prescribed authority.
Senator M. Huffman moved S.C.R. No. 13, seconded by Senator O'Brien. S.C.R. No. 13 was referred to the floor by a vote of 13-0.

The Chair called up S.R. No. 406 (Craig/Antonio) To designate April 26, 2020, as Diabetic Ketoacidosis (DKA) Day.
Senator O'Brien moved S.R. No. 406, seconded by Senator Burke. S.R. No. 406 was referred to the floor by a vote of 13-0.

The Chair called up S.B. No. 204 (Schuring/Sykes) Authorize creation of airport development districts.
Senator Wilson moved S.B. No. 204, seconded by Senator Yuko. S.B. No. 204 was referred to the floor by a vote of 13-0.

The Chair called up S.B. No. 252 (Hackett/Craig) Prohibit "fail first" drug coverage for advanced spreading cancer.
Senator Dolan moved S.B. No. 252, seconded by Senator O'Brien. S.B. No. 252 was referred to the floor by a vote of 13-0.

The Chair called up S.B. No. 277 (Schuring) Change Ohio Pooled Collateral Program.
Senator Thomas moved S.B. No. 277, seconded by Senator Wilson. S.B. No. 277 was referred to the floor by a vote of 13-0.

The Chair called up S.B. No. 308 (M. Huffman) Regards civil liability of service providers in emergency.
Senator Hottinger moved S.B. No. 308, seconded by Senator Eklund. S.B. No. 308 was referred to the floor by a vote of 10-3 (Senators O'Brien, Thomas and Yuko voting no).

There being no further business to come before the committee, Senator Coley moved that the meeting be adjourned. Senator O'Brien seconded the motion.
Hearing no objections, Chairman Obhof adjourned the meeting.
