Committee on Rules and Reference Minutes
July 21, 2020
133rd General Assembly

Chairman Obhof called the meeting to order.
Attendance was taken. A quorum was present.

The Chair called for a motion to accept the minutes of the previous meeting. Senator Williams moved that the minutes be accepted without changes or corrections. Senator O'Brien seconded the motion. Hearing no objections, the minutes of the previous meeting were accepted as written.

The first order of business was the recommittal of H.B. No. 339 (Merrin) - Enacts the Insurance Code Correction Act. Senator Wilson moved that H.B. No. 339 be recommitted to the Insurance and Financial Institutions Committee. Senator Eklund seconded the motion. H.B. No. 339 was recommitted by a vote of 14-0 and the report was properly signed.

The second order of business was the Reference Report for Tuesday, July 21, 2020. Senator Dolan moved that the report be referred to the floor. Senator Kunze seconded the motion. The report was referred to the floor by a vote of 14-0 and the report was properly signed.

The third order of business was the calendar for July 21, 2020:

The Chair called up S.C.R. No. 10 (Lehner) - Approve rules establishing local public health standards.

Senator O'Brien moved S.C.R. No. 10, seconded by Senator Burke. S.C.R. No. 10 was referred to the floor by a vote of 14-0.

The Chair called up H.B. No. 123 (Holmes, G/Manning, G.) - Regards school security and youth suicide awareness/training.

Senator O'Brien moved H.B. No. 123, seconded by Senator M. Huffman. H.B. No. 123 was referred to the floor by a vote of 14-0.

The Chair called up H.B. No. 230 (Crossman) - Designate Brain Cancer Awareness Month.

Senator Kunze moved H.B. No. 230, seconded by Senator Eklund. H.B. No. 230 was referred to the floor by a vote of 14-0.

The Chair called up S.B. No. 174 (Kunze) - Designate Ohio Grateful Patient Day.

Chairman Obhof moved S.B. No. 174, seconded by Senator Yuko. S.B. No. 174 was referred to the floor by a vote of 14-0.

The Chair called up S.B. No. 276 (Roegner/Manning) - Enact Ohio Revised Limited Liability Company Act.

Senator Eklund moved S.B. No. 276, seconded by Senator Thomas. S.B. No. 276 was referred to the floor by a vote of 14-0.

There being no further business to come before the committee, Senator Coley moved that the meeting be adjourned. Senator O'Brien seconded the motion.
