



## Committee Minutes

Chairman Ginter called the meeting of the Community and Family Advancement Committee to order with a prayer at 3:09 p.m.

- The roll was taken; a quorum was present.
- Chairman Ginter reminded those in attendance of the committee's standard media procedures.

Chairman Ginter called HB 187 for its second hearing

- Ken Davis is called to testify.
- Chairman Ginter asked the committee to review the minutes from the previous hearing. Hearing no objections, the minutes stood approved.

Chairman Ginter called HB 64 for its fourth hearing

- Chairman Ginter asked if anyone was wishing to testify before committee.
- Chairman Ginter directed the committee members to review written testimony from the City of Youngstown.

Chairman Ginter called HB 50 for its sixth hearing

- Chairman Ginter called for committee to recess at 3:17 p.m.
- Chairman Ginter reconvened the committee at 4:21 p.m.
- Vice Chair Conditt motioned to adopt amendment AM 0148 to HB 50
  - o Objection made. Chairman Ginter asked the clerk to take the roll. The amendment was adopted with eight affirmative votes, and four negative votes.
- Vice Chair Conditt motioned to adopt amendment AM 0210 to HB 50
  - o Objection made. Chairman Ginter asked the clerk to take the roll. The amendment was adopted with eight affirmative votes, and four negative votes.
- Ranking Member Boyd motioned to adopt amendment AM 0331X2 to HB 50
  - o Representative LaTourette motioned to adopt amendment AM 0348-1 to AM 0331X2.

- Objection made. Chairman Ginter asked the clerk to take the roll. The amendment to the amendment was adopted with nine affirmative votes, and four negative votes.
  - Chairman Ginter asked the clerk to take the roll for AM 0331X2, as amended. The amendment as amended to HB 50 was adopted with nine affirmative votes, and four negative votes.
- Chairman Ginter called for committee to recess at 4:32 p.m.
- Chairman Ginter reconvened the committee at 4:57 p.m. and announced that, pursuant to House Rule 42, AM 0331X2 was out of order and therefore should not have been considered by the committee.
- Representative Boyd agreed to withdraw AM 0331X2 from HB 50, after it was deemed out of order, and no members objected.
- Vice Chair Conditt motioned to vote on HB 50
  - Chairman Ginter asked the clerk to take the roll. The bill was passed out of committee with nine affirmative votes, and five negative votes.
- Chairman Ginter directed LSC to incorporate the accepted amendments into a substitute bill.
