BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That sections 317.241 and 5902.05 of the	4
Revised Code be enacted to read as follows:	5
Sec. 317.241. (A) The county recorder may issue an Ohio	6
veterans identification card to an individual who has met the	7

(1) Presented the individual's armed forces discharge	9

An Ohio veterans identification card expires ten years	17
after the date of issuance. A veteran whose identification card	18
has expired may apply to a county recorder for the issuance of a	19
new identification card, and a veteran whose current card has	20
been lost or damaged, may apply to a county recorder for a	21
replacement identification card, by meeting the requirements	22
described in this section.	23

(C) Fees collected under this section shall be deposited	42
into the county treasury to the credit of the county recorder's	43

technology fund established under section 317.321 of the Revised	44
Code. If no such fund exists, the fee shall be deposited into	45

material and design standards shall be prescribed in rules	84

The rules shall require that an Ohio identification card	86

include the name of this state, a distinguishing number assigned	
to the cardholder, a color photograph of the cardholder, the	88
