Sec. 701.120. (A) There is hereby established the Local	17
Government Safety Capital Grant Program to be administered by	18
the Local Government Innovation Council created in section	19
189.03 of the Revised Code. Under the program, the Council may	20
award grants to political subdivisions to be used for the	21
purchase of vehicles, equipment, facilities, or systems needed	22
to enhance public safety. Applications shall be submitted to the	23
