#### **INTRODUCTION OF BILLS**

The following bill was introduced:

H. B. No. 65-Representative Driehaus.

Cosponsors: Representatives Ramos, Cera, Antonio, Lepore-Hagan, Leland, Phillips, Blessing, Reece, Curtin, Smith, K., Fedor, Celebrezze.

To enact sections 5703.95, 5703.951, 5703.952, 5703.953, and 5703.954 of the Revised Code to provide for the periodic appraisal of the effectiveness of tax expenditures.

Said bill was considered the first time.

**H. B. No. 57** - Representative Maag TO CHANGE THE SENTENCE FOR AGGRAVATED MURDER. To the committee on Judiciary

H. B. No. 58 - Representatives Cera and Rogers TO REQUIRE MOTOR VEHICLE OPERATORS TO TAKE CERTAIN ACTIONS UPON APPROACHING A STATIONARY WASTE COLLECTION VEHICLE COLLECTING REFUSE ON A ROADSIDE. To the committee on Transportation and Infrastructure

**H. B. No. 59** - Representative Cera TO INCREASE TO TEN YEARS THE MANDATORY PRISON TERM FOR A PERSON WHO IS CONVICTED OF A FELONY AND WHO POSSESSED A FIREARM WHILE COMMITTING THE FELONY, IF THE PERSON DISPLAYED OR BRANDISHED THE FIREARM, INDICATED POSSESSION OF IT, OR USED IT TO FACILITATE THE FELONY OR IF THE FIREARM WAS AN AUTOMATIC FIREARM OR WAS EQUIPPED WITH A MUFFLER OR SILENCER. **H. B. No. 62** - Representative Buchy TO DESIGNATE THE SECOND WEEK OF SEPTEMBER AS "KRABBE DISEASE AWARENESS WEEK." To the committee on Health and Aging

H. B. No. 63 - Representatives Pelanda and Grossman TO REQUIRE MANDATORY REPORTERS OF CHILD ABUSE OR NEGLECT TO NOTIFY THE COUNTY PUBLIC CHILDREN SERVICES AGENCY WHEN AN ATTORNEY IN FACT UNDER A DOCUMENT THAT PURPORTS TO GRANT PARENTAL RIGHTS REQUESTS SERVICES FROM THEM, TO REQUIRE THE AGENCY TO INVESTIGATE THE CHILD'S PLACEMENT WITH THE ATTORNEY IN FACT, AND TO REQUIRE THE AGENCY TO FILE A DEPENDENCY COMPLAINT IF IT DETERMINES THAT THE PLACEMENT IS UNSAFE FOR THE CHILD.
