INTRODUCTION OF BILLS

The following bills and joint resolution were introduced:

H. B. No. 91-Representative Green.

To amend section 5705.19 of the Revised Code to lengthen the maximum term of a property tax levied for the purpose of operating a cemetery.

H. B. No. 92-Representative Hagan.

Cosponsors: Representatives Grossman, Brenner, Maag, Hood, Becker, Slaby, Fedor, Rezabek, Thompson.

To amend section 2907.03 of the Revised Code to prohibit an employee of a public or nonpublic school or institution of higher education who is not in a position of authority from engaging in sexual conduct with a minor at least four years younger than the employee who is enrolled in or attends that public or nonpublic school or who is enrolled in or attends that institution of higher education.

H. B. No. 93-Representatives Baker, Landis.

To amend section 959.99 and to enact section 959.133 of the Revised Code to prohibit a person from negligently allowing an animal to be tethered outdoors under specified circumstances.
