**INTRODUCTION OF BILLS**

The following bill was introduced:

**H. B. No. 123** - Representatives Johnson, G., Cupp.

Cosponsors: Representatives Butler, Rogers, Stinziano, O'Brien, S., Rezabek.

To amend sections 2945.58 and 2951.03 of the Revised Code to change the time for notification of an alibi defense in a criminal case, to allow the court in a felony case to impose community control sanctions without a presentence investigation report upon agreement of the defendant and the prosecutor, and to request the Supreme Court to modify Criminal Rule 32.2 to allow the court in a felony case to impose community control sanctions without a presentence investigation report upon agreement of the defendant and the prosecutor.

Said bill was considered the first time.

### BILLS FOR THIRD CONSIDERATION

**H. B. No. 40**-Representatives Gonzales, Dever.

To amend sections 4730.14, 4731.22, 4731.222, 4731.225, 4731.24, 4731.281, and 4778.06 and to enact sections 4730.252, 4760.133, 4762.133, 4774.133, and 4778.141 of the Revised Code to authorize the State Medical Board to impose fines rather than licensing suspensions for failure to comply with continuing education requirements, to authorize the Board to impose fines in addition to other actions it may take for violations of the laws it administers, and to authorize the Board to impose additional conditions for restoration of certain certificates to practice, was taken up for consideration the third time.
