To amend sections 3717.22 and 4301.62 and to enact section 4303.2010 of the Revised Code to establish the F-10 liquor permit to authorize certain A-2 permit holders to sell Ohio wines at farmers markets.

H. B. No. 179 - Representatives Stinziano, Sykes.

Cosponsors: Representatives Bishoff, Boyd, Cera, Curtin, Johnson, G., Leland, Lepore-Hagan, Phillips, Ramos, Sheehy, Smith, K.

To amend sections 3501.05, 3503.09, 3503.12, 3503.13, 3503.14, 3503.15, 3503.16, 3503.19, 3503.21, 3503.28, 3503.30, 3503.33, 3505.18, 3505.181, 3505.183, 3509.03, 3509.05, 3511.02, 3511.09, 3599.11, 3599.18, 4501.023, 4503.03, 4503.10, 4506.04, 4506.07, 4507.05, 4507.06, 4507.09, 4507.36, and 4507.51; to enact new section 3503.11; to repeal sections 3503.11 and 3503.29 of the Revised Code; and to amend the versions of sections 4507.05 and 4507.06 of the Revised Code that are scheduled to take effect January 1, 2017, to continue the provisions of this act on and after the effective date, to require that eligible persons in the database of the Bureau of Motor Vehicles be automatically registered to vote or have their registrations updated automatically, as applicable, unless those persons decline to be registered or to update their registrations.
