## FORTY-NINTH DAY

The House met pursuant to adjournment.

Pursuant to House Rule No. 23, the Clerk called the House to order.

Representative Brenner was selected to preside under the Rule.

The journal of the previous legislative day was read and approved.

**INTRODUCTION OF BILLS**

The following bills were introduced:

**H. B. No. 194** - Representative Roegner.

Cosponsors: Representatives Brown, Becker, Vitale, Terhar, Hood, Kraus, Romanchuk, Blessing.

To enact sections 2307.66 and 2307.67 of the Revised Code to prohibit a person from engaging in the widespread sending of bad faith, objectively baseless communications of patent infringement and to authorize the Attorney General to investigate and institute a civil action if the Attorney General believes a person has made such assertions of patent infringement.

**H. B. No. 195** - Representative Grossman.

Cosponsors: Representatives Blessing, Boose, Hackett, Stinziano, Landis, Kraus, Slaby, Antani, Bishoff, Craig.

To amend section 4501.21 and to enact section 4503.87 of the Revised Code to create the "Dream Field" license plate.

**H. B. No. 196** - Representatives Amstutz, Derickson.

Cosponsors: Representatives Grossman, Smith, R., Ryan, Hambley, Sprague, Rezabek, Blessing, Romanchuk, Scherer, Johnson, T.

To amend sections 355.02, 355.03, 355.04, 5101.90, 5101.91, 5101.92, 5108.01, 5108.04, 5108.06, 5108.07, 5108.09, and 5108.11; to amend, for the purpose of adopting new section numbers as indicated in parentheses, sections 5108.03 (5108.05) and 5108.05 (5108.041); to enact new section 5108.03 and sections 5101.901, 5101.902, 5101.93, 5108.021, and 5108.022; and to repeal section 5108.03 of the Revised Code and to repeal Section 551.10 of Am. Sub. H.B. 483 of the 130th General Assembly to require boards of county commissioners to establish local healthier buckeye councils; to rename the Ohio Healthier Buckeye Advisory Council the Ohio Healthier Buckeye Council and to expand its duties; to establish the Healthier Buckeye Grant Program; to establish the Comprehensive Case Management and Employment Program; and to make changes to the law governing the Prevention, Retention, and Contingency Program.

**H. B. No. 197** - Representative Rezabek.

Cosponsors: Representatives Johnson, T., Sprague, O'Brien, M., Manning, Boose, Koehler, LaTourette, Smith, R.

To enact section 2925.62 of the Revised Code to prohibit the over-the-counter sale, without a prescription, of dextromethorphan to a person who is under 18 years of age.

**H. B. No. 198** - Representatives Hambley, Johnson, G.

Cosponsors: Representatives Bishoff, Boose, Hackett, Hill, Green, O'Brien, M.

To repeal section 2931.18 of the Revised Code to abolish the humane society's authority to employ an attorney to prosecute certain violations of law dealing with animal cruelty or acts involving mistreatment or nonsupport of children.

**H. B. No. 199** - Representatives Blessing, Rezabek.

Cosponsor: Representative Green.

To amend sections 4775.01, 4775.02, 4775.03, 4775.04, 4775.05, 4775.06, 4775.07, 4775.08, 4775.09, 4775.10, and 4775.11 of the Revised Code to extend the jurisdiction of the Motor Vehicle Repair Board to persons who perform motor vehicle mechanical repairs, to require motor vehicle repair facilities to register with the Board, and to make other changes to the Motor Vehicle Repair and Window Tint Operator Law, and to further enact new section 4775.03 and repeal section 4775.03 of the Revised Code on January 1, 2016, to dissolve the existing Motor Vehicle Repair Board and replace it with a new board of the same name.

Said bills were considered the first time.
