INTRODUCTION OF BILLS

The following bills and joint resolution were introduced:

H. B. No. 259 - Representatives Ryan, Sears.

To enact sections 3938.01, 3938.02, 3938.03, 3938.04, 3938.05, 3938.06, 3938.07, 3938.08, and 3938.09 of the Revised Code to regulate certificates of insurance prepared or issued to verify the purchase of property or casualty insurance coverage.

H. B. No. 260 - Representative Blessing.

To amend section 5.2240 of the Revised Code to designate the first week of December as "Crohn's and Colitis Awareness Week."

H. J. R. No. 4 - Representatives Smith, R., Curtin.

Proposing to amend Sections 1a, 1b, and 1e of Article II of the Constitution of the State of Ohio to prohibit an initiated constitutional amendment that would grant a monopoly or a special economic interest, privilege, benefit, right, or license to any person or entity and to modify the procedure to propose a law or a constitutional amendment by initiative petition.
