### INTRODUCTION OF BILLS

The following bills were introduced:

**H. B. No. 270** - Representatives Dever, Pelanda.

To amend section 2903.04 of the Revised Code to provide that causing the death of another person by an overdose that results from the offender's sale, distribution, dispensation, or administration of a controlled substance or controlled substance analog is a violation of the offense of involuntary manslaughter and to make this provision a strict liability offense.

**H. B. No. 271** - Representatives Smith, R., Ryan.

To enact section 5534.19 of the Revised Code to designate a portion of State Route 93 within Jackson County as the "Lieutenant Stephen Byus Memorial Highway."

**H. B. No. 272** - Representatives Johnson, G., Sykes.
