**INTRODUCTION OF BILLS**

The following bills were introduced:

**H. B. No. 301** - Representatives Henne, Huffman.

Cosponsors: Representatives Hambley, Thompson, Vitale, Becker, Sears, Schaffer, Burkley, Retherford, Sprague.

To enact section 124.824 of the Revised Code to require the Department of Administrative Services to make a high deductible health care plan available to state employees and state elected officials.

**H. B. No. 302** - Representatives Henne, Butler.

Cosponsor: Representative Duffey.

To amend section 709.023 of the Revised Code to provide that, beginning five years after a type-II annexation is approved, the annexed territory is subject to a fire, police, or EMS tax levy only if the levy is imposed by the subdivision that provides the fire, police, or EMS service to the territory.

Said bills were considered the first time.
