The House met pursuant to adjournment.

Pursuant to House Rule No. 23, the Clerk called the House to order.

Representative Brenner was selected to preside under the Rule.

The journal of the previous legislative day was read and approved.

INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 306 - Representative Perales.

Cosponsors: Representatives Hill, O'Brien, M., Ruhl, Ramos.

To amend sections 3737.82, 3781.10, 3781.104, and 4740.14 and to enact section 2305.403 of the Revised Code to require a separate, exterior means of egress for dwelling areas above the second story of certain residential rental properties and to provide a qualified immunity to landlords who in good faith comply with the requirement.

H. B. No. 307 - Representative Pelanda.

Cosponsors: Representatives Becker, Brenner, Dever, Johnson, G., Hackett.

To amend sections 2925.02, 2925.03, 2925.04, 2925.041, 2925.05, 2925.06, 2925.11, 2925.12, 2925.13, 2925.14, 2925.141, 2925.22, 2925.23, 2925.31, 2925.32, 2925.33, 2925.36, 2925.37, 4510.021, 4510.17, and 4510.31 of the Revised Code to make the suspension of an offender's driver's license for a violation of specified drug offenses discretionary rather than mandatory, to authorize a court to terminate a driver's license suspension imposed for specified drug offenses committed out-of-state, to generally authorize a court to terminate a previously imposed mandatory suspension for specified drug offenses, to provide for the discretionary suspension of an offender's driver's license for possessing nitrous oxide in a motor vehicle, and to make consistent the provisions of law governing the ability of a court to grant limited driving privileges.

H. B. No. 308 - Representatives Duffey, Stinziano. Cosponsors: Representatives Antani, Bishoff, Boyd, Derickson, Grossman, Hood, Lepore-Hagan, Ramos, Reece, Rogers, Slesnick, Patterson.

To amend sections 5739.02 and 5739.03 of the Revised Code to exempt from sales and use tax textbooks purchased by post-secondary students.

H. B. No. 309 - Representative Clyde.

Cosponsors: Representatives Lepore-Hagan, Fedor, Smith, K., Antonio,

Phillips, Ramos.

To amend section 3509.05 of the Revised Code to eliminate the requirement that absent voter's ballots received during the ten days after the day of an election contain a postmark and to specify circumstances under which those ballots must not be counted.

H. B. No. 310 - Representatives Ryan, Ginter.

Cosponsors: Representatives Landis, Grossman, Hackett, Vitale, Romanchuk, Derickson, Dever, Sheehy, Perales.

To enact section 4503.434 of the Revised Code to establish the "Distinguished Flying Cross" license plate.

H. B. No. 311 - Representative Schuring.

To enact section 3305.063 of the Revised Code to base the percentage of an employee's salary that must be contributed to the State Teachers Retirement System to mitigate the effect of the employee's participation in an alternative retirement program on the average percentage used to amortize the Retirement System's unfunded actuarial accrued pension liabilities.

H. B. No. 312 - Representative Anielski.

To amend section 4501.21 and to enact section 4503.873 of the Revised Code to create the "Brecksville-Broadview Heights City Schools" license plate.

H. B. No. 313 - Representative Anielski.

Cosponsor: Representative Patmon.

To amend section 4501.21 and to enact section 4503.87 of the Revised Code to create the "Cleveland St. Ignatius High School" license plate.

H. B. No. 314 - Representative Anielski.

To amend section 4501.21 and to enact section 4503.874 of the Revised Code to create the "Lakewood St. Edward High School" license plate.

H. B. No. 315 - Representative Anielski.

To amend section 4501.21 and to enact section 4503.871 of the Revised Code to create the "Solon City Schools" license plate.

H. B. No. 316 - Representative Anielski.

To amend section 4501.21 and to enact section 4503.872 of the Revised Code to create the "Mayfield City Schools" license plate.
