**INTRODUCTION OF BILLS**

The following bills were introduced:

**H. B. No. 338** - Representative Romanchuk.

To enact section 5534.29 of the Revised Code to designate a portion of I-71 in Richland County as the "Lt. Col. Albert L. Allen, Jr. Memorial Highway."

To enact section 2701.01 of the Revised Code to prohibit courts, administrative agencies, and arbitrators from applying foreign law to the detriment of constitutional rights under the United States and Ohio constitutions.

To amend sections 4505.101, 4513.60, 4513.601, 4513.61, 4513.611, 4513.68, and 4921.25 and to enact sections 4505.103 and 4511.044 of the Revised Code to require the Public Utilities Commission to raise the existing statutorily designated towing and storage fees annually by the percentage increase in the consumer price index, to establish a \$35 fee for the retrieval of nonmedical personal items from a motor vehicle, to modify the civil penalties

applicable to violations of the towing law, to modify the calculation of the value of an abandoned vehicle to which a towing service or storage facility seeks to take title, and to make other changes to the towing law.
