INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 362 - Representatives Stinziano, Kunze.

To amend section 2929.14 and to enact section 2903.17 of the Revised Code to prohibit a person from knowingly impeding the normal breathing or circulation of another by strangulation.

H. B. No. 363 - Representative Reece.

To enact section 2151.351 of the Revised Code to require restraints to be removed from an alleged or adjudicated delinquent child prior to the commencement of a juvenile court hearing or proceeding unless the court determines that the use of restraints is necessary to prevent physical harm to the child or another person or to prevent the child from escaping.

H. B. No. 364 - Representative Ginter.

To enact section 5534.24 of the Revised Code to designate a portion of State Route 7 within Columbiana County as the "Corporal William F. Bratt Memorial Highway."

To amend sections 2929.03, 2953.21, and 2953.23 of the Revised Code to require the clerk of a common pleas court to retain a copy of the original trial file when a death penalty is imposed, to specify that there is no page limit on petitions for postconviction relief in death penalty cases or in appeals of denials of such relief, to modify the time for filing an amended postconviction relief petition in death penalty cases, to provide for depositions and subpoenas during discovery in postconviction relief proceedings in death penalty cases, and to require a judge hearing a postconviction relief proceeding in a death penalty case to state specifically in the findings of fact and conclusions of law why each claim was either denied or granted.
