INTRODUCTION OF BILLS

The following bill was introduced:

H. B. No. 398 - Representative Hill.

To amend sections 5713.31, 5713.34, and 5715.01 of the Revised Code to require that the computation of the capitalization rate for the purposes of determining CAUV of agricultural land be computed using a method that excludes appreciation and equity buildup and to stipulate that CAUV land used for a conservation practice or enrolled in a federal land retirement or conservation program for at least three years must be valued at the lowest of the values assigned on the basis of soil type.

Said bill was considered the first time.

The question being on the adoption of the concurrent resolution, reading as follows:

H. C. R. No. 31-Representative Derickson.

To urge the President of the United States to halt the settlement of Syrian refugees in Ohio and the United States.

WHEREAS, Since 2011, conflict in the Syrian Arab Republic has displaced roughly four million Syrian nationals, many of whom have fled to other Arab nations and to Europe; and

WHEREAS, The United States of America has recently intensified the resettlement of Syrian national refugees due to increased conflict perpetuated by the Islamic State of Iraq and Syria; and

WHEREAS, It is possible that members of the Islamic State of Iraq and Syria, or another radical extremist terrorist organization, could infiltrate the State of Ohio and the United States of America by claiming Syrian refugee status; and

WHEREAS, It is not possible to adequately investigate the legitimacy of each claim of refugee status to prevent members of the Islamic State of Iraq and Syria from entering the United States; and

WHEREAS, Security concerns continue to mount regarding the resettlement of Syrian nationals to the State of Ohio and the United States of America; now therefore be it

RESOLVED, That we, the members of the 131st General Assembly of the State of Ohio urge the President of the United States to prevent the resettlement of Syrian refugees into the State of Ohio as well as the United States of America; and be it further

RESOLVED, That the Clerk of the House of Representatives is hereby directed to transmit duly authenticated copies of this resolution to the President of the United States, to the United States Secretary of Homeland Security, to the Director of the United States Citizenship and Immigration Services, to the Speaker and Clerk of the United States House of Representatives, to the President Pro Tempore and the Secretary of the United States Senate, to the members of the Ohio Congressional delegation, and to the news media of Ohio.

BILLS FOR THIRD CONSIDERATION

Sub. H. B. No. 294—Representatives Patmon, Conditt.

Cosponsors: Representatives Brenner, Hood, Terhar, Roegner, Butler, Vitale, Perales, Sprague, Blessing, Becker, Antani, Retherford, Brinkman, Hagan, Koehler, Hayes, Schaffer, Maag, Hambley, Thompson, McClain, Hall, Hill.

To enact section 3701.034 of the Revised Code to require the Department of Health to ensure that state funds and certain federal funds are not used

either to perform or promote nontherapeutic abortions, or to contract or affiliate with any entity that performs or promotes nontherapeutic abortions, was taken up for consideration the third time.

The question being, "Shall the bill pass?"

Representative Howse moved to amend, amendment 1381, as follows:

In line 1 of the title, delete "section" and insert "sections"; after "3701.034" insert "and 3701.035"

In line 7 of the title, after "abortions" insert "and to require the Department to investigate and issue a report on the expected impact of the funding-use restrictions prior to their application"

In line 8, delete "section" and insert "sections"; after "3701.034" insert "and 3701.035"

In line 10, delete "(A)" and insert "The department of health shall take no action required under this section unless the department issues the report under section 3701.035 of the Revised Code and the report finds that no services or benefits would be lost to individuals either across the board or in certain geographical areas pursuant to division (C) of that section and no job losses would result pursuant to division (D) of that section.

(A)"

In line 44, delete "of health"

After line 109, insert:

"Sec. 3701.035. The department of health shall investigate and, not later than one year after the effective date of this section, issue a report of its findings to the governor and the general assembly addressing the following regarding the expected impact of section 3701.034 of the Revised Code:

(A) A list and description of organizations and entities whose funding would be impacted;

(B) The specific programs within the organizations and entities under division (A) of this section that would be impacted, and how;

(C) A summary of nonidentifying information regarding individuals currently receiving services or benefits under the programs under division (B) of this section, including:

(1) How these individuals would be impacted;

(2) How many of these individuals would be impacted;

(3) A breakdown of the races and ethnicities of the individuals impacted;

(4) A breakdown of the ages of the individuals impacted; and

(5) Any demographic disparities among the individuals impacted.

(D) The number of jobs that potentially would be lost as a result of the funding impact on the programs described under division (B) of this section;

(E) A cost-benefit analysis of maintaining the programs described under division (B) of this section versus the expected results of the application of section 3107.034 of the Revised Code."

(b) Recognized as medically sound and objective by leading medical organizations with relevant expertise, such as the American medical association, the American congress of obstetricians and gynecologists, the American public health association, the American college of physicians, the American academy of family physicians, and the American psychological association; government agencies such as the United States centers for disease control, the United States food and drug administration, the national cancer institute, and the national institute of health; and scientific advisory groups such as the institute of medicine and the advisory committee on immunization practices; or

(c) Recommended by or affirmed in the medical practice guidelines of a nationally recognized accrediting organization."

After line 109, insert:

"(H) Any school that receives funding through or from the state and provides sexual education to any of its students shall provide medically accurate information as part of the school's sexual education program, whether orally or in written materials."

In line 7 of the title, after "abortions" insert ", and to require crisis pregnancy centers that receive state funds to provide only medically accurate information"

After line 43, insert:

"(9) "Medically accurate information" means information that is:

(a) Verified or supported by the weight of peer-reviewed medical research conducted in compliance with accepted scientific methods;

(b) Recognized as medically sound and objective by leading medical organizations with relevant expertise, such as the American medical association, the American congress of obstetricians and gynecologists, the American public health association, the American college of physicians, the American academy of family physicians, and the American psychological association; government agencies such as the United States centers for disease control, the United States food and drug administration, the national cancer institute, and the national institute of health; and scientific advisory groups such as the institute of medicine and the advisory committee on immunization practices; or

(c) Recommended by or affirmed in the medical practice guidelines of a nationally recognized accrediting organization.

(10) "Crisis pregnancy center" means a facility, licensed or otherwise, and including mobile facilities, the primary purpose of which is to provide services to women who are or may be pregnant, that either:

(a) Offers obstetric ultrasounds, obstetric sonograms, or prenatal care to pregnant women; or

(b) Has the appearance of a medical facility.

(11) It is prima facie evidence that a facility has the "appearance of a medical facility" if two or more of the following factors are present:

(a) The facility offers pregnancy testing or pregnancy diagnosis.

(b) The facility has staff or volunteers who wear medical attire or uniforms.

(c) The facility contains one or more examination tables.

(d) The facility contains a private or semiprivate room or area containing medical supplies and medical instruments.

(e) The facility has staff or volunteers who collect health information from clients.

(f) The facility is located on the same premises as a state-licensed medical facility or provider or shares facility space with a state-licensed medical provider."

After line 109, insert:

"(H) The state shall ensure that it does not distribute any funds or grants, regardless of their origin, to any crisis pregnancy center that provides, either orally or in writing to women seeking information and counseling, any information related to pregnancy, birth control, abortion, sexually transmitted diseases including HIV/AIDS, or human reproduction or sexuality, that is not medically accurate. This includes information related to the woman's health status or medical diagnosis or prognosis."
