INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 424 - Representative Antani.

Cosponsors: Representatives Terhar, Blessing, Young, Johnson, T., Schaffer.

To amend section 149.43 of the Revised Code to specify that military records provided by an officer or employee of a township or municipal corporation to the township or municipal corporation for personnel matters are not public records.

H. B. No. 425 - Representative Hayes.

Cosponsors: Representatives Becker, Green, Hood, Retherford, Romanchuk, Thompson.

To amend sections 3313.601, 3314.03, 3326.11, and 3328.24 and to enact sections 3320.01, 3320.02, and 3320.03 of the Revised Code regarding student religious expression.

H. B. No. 426 - Representative Antani.

Cosponsors: Representatives Anielski, Boccieri, Duffey.

To amend section 3332.031 and to enact section 3333.0414 of the Revised Code to require the State Board of Career Colleges and Schools to report and post job placement information.

H. B. No. 427 - Representative Antani.

Cosponsors: Representatives Manning, Becker, Sweeney, Fedor, Sheehy.

To amend sections 2953.32, 2953.37, 2953.38, and 2953.53 and to enact sections 109.38 and 109.381 of the Revised Code to require the Attorney General to select a qualified third party to receive court notices of sealed or expunged criminal records and to require identified data repositories and web sites that receive those notices from the qualified third party to remove those records from their databases.

H. B. No. 428 - Representative Antani.

To amend section 4501.21 and to enact section 4503.577 of the Revised Code to create the "National Aviation Hall of Fame" license plate.

H. B. No. 429 - Representatives Antani, Reineke.

Cosponsors: Representatives Duffey, Hackett, Young, Grossman.

To amend Section 257.30 of Am. Sub. H.B. 64 of the 131st General Assembly regarding employers of automotive technicians and motor vehicle technicians participating in the Incumbent Workforce Training Voucher Program.

H. B. No. 430 - Representative Sprague.

Cosponsors: Representatives Blessing, Buchy, Burkley, Cupp, Dever, Grossman, Huffman, Sheehy.

To enact section 5534.55 of the Revised Code to designate a portion of U.S. Route 30 in Hancock County as the "Congressman Michael G. Oxley Memorial Highway."
