The House met pursuant to adjournment.

Pursuant to House Rule No. 23, the Clerk called the House to order.

Representative Ruhl was selected to preside under the Rule.

The journal of the previous legislative day was read and approved.

### INTRODUCTION OF BILLS

The following bills were introduced:

**H. B. No. 504** - Representative Schuring.

To amend section 3333.0412 of the Revised Code to generally protect a private, nonprofit institution of higher education from liability for a breach of confidentiality or other claim that arises from the institution's disclosure of public records.

**H. B. No. 505** - Representatives Huffman, Pelanda.

Cosponsors: Representatives Becker, Johnson, T., Sprague, Ginter.

To amend sections 3715.01, 3715.64, 4729.01, 4729.38, and 4729.99 and to enact section 3715.011 of the Revised Code regarding the regulation of biological products and the substitution of interchangeable biological products when dispensed by pharmacists.

**H. B. No. 506** - Representatives Johnson, G., Smith, K.

Cosponsors: Representatives Antonio, Boyd, Curtin, Phillips, Ramos, Lepore-Hagan.

To amend sections 117.01 and 187.03 and to enact section 187.14 of the Revised Code to allow the Auditor of State to conduct full audits of JobsOhio, to require all nonprofit economic development corporations that receive public funds to make annual disclosures related to both their public and private funds, and to require that JobsOhio submit a quarterly progress report detailing all of its active projects.

**H. B. No. 507** - Representative Bocchieri.

To enact section 5.234 of the Revised Code to designate May 15th as "All for the Kids Awareness Day."

**H. B. No. 508** - Representatives Smith, K., Boggs.

Cosponsors: Representatives Driehaus, Johnson, G., Antonio, O'Brien, M., Patterson, Phillips, Fedor, Slesnick, Lepore-Hagan, Strahorn, Bishoff.

To make supplemental appropriations to the Auditor of State for purposes of distributing these funds to political subdivisions in fiscal caution, watch, or emergency.

**H. B. No. 509** - Representative Scherer.

Cosponsors: Representatives Becker, Brenner, Grossman, Perales, Rogers, Ruhl.

To amend sections 307.94, 703.20, and 703.21 of the Revised Code to allow electors of a village to petition the board of elections, as an alternative to the legislative authority, for the dissolution of the village, to provide for the timely transfer of village property and services with the assistance of the Auditor of State, to require the Auditor of State to perform and complete an audit or agreed-upon procedures before transferring any cash balances to a township following a village dissolution, and to modify the deadline to file a county charter petition with the board of county commissioners.

To amend sections 109.84, 126.30, 145.2915, 2307.84, 2307.91, 2307.97, 2317.02, 2913.48, 3121.899, 3701.741, 3963.10, 4115.03, 4121.03, 4121.12, 4121.121, 4121.125, 4121.127, 4121.129, 4121.30, 4121.31, 4121.32, 4121.34, 4121.36, 4121.41, 4121.44, 4121.441, 4121.442, 4121.444, 4121.45, 4121.50, 4121.61, 4123.15, 4123.26, 4123.291, 4123.311, 4123.32, 4123.324, 4123.34, 4123.341, 4123.343, 4123.35, 4123.351, 4123.353, 4123.402, 4123.441, 4123.442, 4123.444, 4123.47, 4123.51, 4123.511, 4123.512, 4123.53, 4123.54, 4123.542, 4123.57, 4123.571, 4123.65, 4123.68, 4123.93, 4123.931, 4125.03, 4125.04, 4131.01, 4729.80, 5145.163, and 5503.08 and to enact sections 4133.01 to 4133.16 of the Revised Code to modify workers' compensation benefit amounts for occupational pneumoconiosis claims and to create the Occupational Pneumoconiosis Board to determine medical findings for such claims.
