The House met pursuant to adjournment.

Pursuant to House Rule No. 23, the Clerk called the House to order.

Representative Koehler was selected to preside under the Rule.

The journal of the previous legislative day was read and approved.

### INTRODUCTION OF BILLS

The following bills were introduced:

**H. B. No. 529** - Representatives Retherford, Hagan.

Cosponsors: Representatives Hambley, Becker, Koehler.

To amend sections 109.71, 109.73, 109.75, 109.79, 109.801, and 2923.126 and to enact sections 109.748 and 109.771 of the Revised Code to provide for firearms training for tactical medical professionals; to permit such a professional who has received that training or comparable training and who is authorized to carry firearms by the law enforcement agency the professional is serving to carry firearms while on duty in the same manner, to the same extent, in the same areas, and subject to the same potential for civil and criminal liability as a law enforcement officer of the agency; and to grant such a professional, while on duty in that capacity, the same right to carry a concealed handgun in this state as a person who was issued a concealed handgun license.

**H. B. No. 530** - Representative Retherford.

To amend sections 5104.01, 5104.015, and 5104.99 and to enact sections 5104.0113, 5104.15, 5104.16, and 5104.17 of the Revised Code to provide for the licensure of sick-child care centers.

**H. B. No. 531** - Representative Hill.

Cosponsors: Representatives Schaffer, Slaby, Arndt.

To enact sections 505.242 and 507.091 of the Revised Code to require townships to provide mileage reimbursement to a member of a board of township trustees and to a township fiscal officer for travel within the township that is necessary in the performance of the member's or fiscal officer's duties.

**H. B. No. 532** - Representative Smith, R.

To amend sections 4735.01, 4735.06, 4735.07, 4735.09, 4735.10, 4735.141, 4735.18, 4735.24, 4735.51, and 4735.65 and to enact sections

4735.081, 4735.091, and 4735.23 of the Revised Code relating to real estate brokers and salespersons.

**H. B. No. 533** - Representative Sprague.

Cosponsors: Representatives Ramos, Schaffer, Sweeney.

To enact section 5.259 of the Revised Code to designate the month of May as "Neurofibromatosis Awareness Month."

Representative Ryan moved to amend the title as follows:

Representative Ryan moved to amend as follows:

After line 22, insert:

"(E) The board of township trustees may cause the removal of snow and ice from the sidewalk of an owner, occupant, or person who has not complied with the township's resolution. All expenses incurred in causing the removal of the snow and ice shall be paid out of the township general fund from moneys not otherwise appropriated.

(F) The board of township trustees may utilize any lawful means to collect from an owner, occupant, or person a fine assessed against the owner, occupant, or person under this section or expenses incurred in the removal of snow and ice from the owner, occupant, or person's sidewalk under this section. The board may direct the township fiscal officer to certify the fine or expenses and a description of the land to the county auditor, who shall place the fine or expenses upon the tax duplicate as a lien upon the land to be collected as other taxes and returned to the township general fund."
