INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 557 - Representative Clyde.

Cosponsors: Representatives Antonio, Boccieri, Boggs, Cera, Fedor, Lepore-Hagan, O'Brien, M., Phillips, Ramos, Smith, K., Sykes.

To enact section 3501.45 of the Revised Code to create a presumption of validity for certain election matters and to require certain provisional ballots cast in the wrong polling place to be remade and counted.

H. B. No. 558 - Representatives Boccieri, Ramos.

Cosponsors: Representatives O'Brien, M., Antonio, Smith, K., Strahorn, Cera, Rogers, Sheehy, Clyde, Lepore-Hagan, Fedor, Bishoff, Reece.

To amend sections 3314.03, 3326.11, and 3328.24 and to enact sections 3313.461, 3345.90, and 3781.181 of the Revised Code to require the use of domestic steel in construction, repair, or improvement projects involving certain buildings used by public schools, state institutions of higher education, and specified private colleges.

H. B. No. 559 - Representative Cupp.

Cosponsors: Representatives Antani, Becker, Henne, Huffman, McClain, Schaffer, Scherer, Smith, R., Sprague.

To amend sections 2305.113, 2305.252, 2305.51, 2317.421, 2317.43, and 2323.41 and to enact sections 2305.2311, 2317.44, 2317.45, 2323.40, and 2323.451 of the Revised Code to grant qualified civil immunity to certain medical providers who provide emergency medical services as a result of a disaster or mass hazard; to provide that certain communications made regarding an unanticipated outcome of medical care, the development or implementation of standards under federal laws, and an insurer's reimbursement policies on health care are inadmissible as evidence in a medical claim; to provide that medical bills itemizing charges are

inadmissible as evidence and a payment for medical services accepted by a defendant from an insurer is admissible as evidence of the reasonableness of the charges; to specify the manner of sending a notice of intent to file a medical claim and provide a procedure for the discovery of other potential claims within a specified period after the filing of a medical claim; to provide that any loss of a chance of recovery or survival by itself is not an injury, death, or loss for which damages may be recovered; to provide civil immunity to certain medical providers regarding the discharge of a patient with a mental condition that threatens the safety of the patient or others; to require that governmental agencies that receive peer review committee records maintain their confidentiality; and to clarify the definition of "medical claim."

BILLS FOR THIRD CONSIDERATION

Sub. H. B. No. 512-Representative Ginter.

Cosponsor: Representative Landis.

To amend sections 6109.01, 6109.10, 6109.22, 6111.036, and 6121.04, and to enact section 6109.121 of the Revised Code to establish requirements governing lead and copper testing for community and nontransient noncommunity water systems, to revise the law governing lead contamination from plumbing fixtures, and to revise the laws governing the Water Pollution Control Loan Fund, the Drinking Water Assistance Fund, and the Ohio Water Development Authority, was taken up for consideration the third time.

Representative Bocchieri moved to amend, amendment 0026, as follows:

In line 402, after "(J)" insert "(1) The owner or operator of a community or nontransient noncommunity water system along with the applicable emergency management agency established under Chapter 5502. of the Revised Code and local board of health may develop a plan to distribute the public notification required to be made under division (C)(3)(a) of this section. If such a plan is developed, the owner or operator shall submit the plan to the director for approval. The director may approve or deny the plan. If the director denies the plan, the owner or operator shall, together with the applicable emergency management agency and local board of health, modify the plan. The owner or operator shall submit the modified plan for approval not later than thirty days from the date the initial plan was denied.

(2) For purposes of this section, an exceedance of the lead action level established in rules is a public health crisis. If a public health crisis occurs, the owner or operator of a community or nontransient noncommunity water system shall coordinate with the applicable emergency management agency established under Chapter 5502. of the Revised Code and local board of health to distribute the public notification required under division (C)(3)(a) of this section in accordance with a plan for notification, if a plan was developed under division (J)(1) of this section.

(3) The community or nontransient noncommunity water system is financially responsible for distributing notices as required under division (J) (2) of this section.

(K)"
