INTRODUCTION OF BILLS

The following bills were introduced:

To amend sections 1545.05 and 1545.06 of the Revised Code to require boards of county commissioners to appoint additional park board commissioners and allow for public comment during appointment process.

To amend sections 927.72 and 927.99 and to enact section 927.57 of the Revised Code to prohibit the labeling and advertising of nursery stock as pollinator beneficial under specified conditions.
