# **INTRODUCTION OF BILLS**

The following bills were introduced:

### H. B. No. 567 - Representative Driehaus.

To enact section 187.14 of the Revised Code to require that, if JobsOhio provides financial assistance for the cleanup and remediation of brownfields, at least 85% of the assistance must be in the form of grants.

H. B. No. 568 - Representatives Phillips, Rogers.

Cosponsors: Representatives Driehaus, Howse, Lepore-Hagan, Ramos, Smith, K., Strahorn.

To amend sections 121.083, 1349.61, 4111.02, 4111.14, 4113.15, 4115.03, 4121.01, 4123.01, 4123.026, 4141.01, and 5747.01 and to enact sections 4113.83, 4113.84, 4113.85, 4113.86, 4113.87, 4113.88, 4175.01, 4175.02, 4175.03, 4175.04, 4175.05, 4175.06, 4175.07, 4175.08, 4175.09, 4175.091, 4175.10, 4175.11, 4175.12, 4175.13, 4175.14, 4175.15, 4175.16, 4175.17, 4175.18, and 4175.99 of the Revised Code to create a generally uniform definition of employee for specified labor laws, to create a uniform standard to determine whether an individual performing services for an employer is an employee of that employer, and to regulate the payment of wages via payroll card.

H. B. No. 569 - Representative Antonio.

Cosponsors: Representatives Sheehy, Boggs, Brown, Clyde, Lepore-Hagan, Boyd, Boccieri, Reece, Fedor, Leland, Bishoff, Ramos, Driehaus.

To amend section 2927.12 of the Revised Code to rename the offense of ethnic intimidation to bias-motivated crime; to expand the scope of the offense to include specified crimes committed based on a person's actual or perceived ethnicity, gender, sexual orientation, gender identity, or disability; to require peace officer training on bias-motivated crime, and to require law enforcement agencies to submit data on bias-motivated crime to the Ohio Department of Public Safety and the Federal Bureau of Investigation and provide for the annual public release of the data.

H. B. No. 570 - Representative Hill.

To amend sections 3313.64, 3313.98, 3313.981, 3314.08, 3326.31, and 3326.33 of the Revised Code regarding funding for students enrolled in community schools, STEM schools, and other districts through interdistrict open enrollment.

H. B. No. 571 - Representatives Duffey, Boggs.

Cosponsors: Representatives Sweeney, Hagan, Blessing, Romanchuk, Ruhl, Antani, Arndt, Hambley, Baker, Scherer, Perales.

To amend section 3313.471 of the Revised Code regarding the presentation

of career information to students.

**H. B. No. 572 -** Representatives Leland, Sprague. Cosponsors: Representatives Boccieri, Boggs, Johnson, G., Ramos, Rogers, Lepore-Hagan, Smith, K.

To amend section 5747.113 and to enact section 3701.265 of the Revised Code to allow taxpayers to contribute all or a portion of their income tax refunds to support improved cancer reporting through the Ohio Cancer Incidence Surveillance System Fund.

H. B. No. 573 - Representative Scherer.

To amend sections 956.01, 956.13, and 956.18 and to enact sections 956.051, 956.181, 956.19, 956.20, 956.21, 956.22, 956.23, and 956.99 of the Revised Code to regulate the sale of dogs from pet stores and dog retailers and to require the Director of Agriculture to license pet stores.

Said bills were considered the first time.
