The journal of the previous legislative day was read and approved.

INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 607 - Representatives Patterson, Sheehy.

Cosponsors: Representatives Fedor, Boggs, Smith, K., O'Brien, M.

To amend sections 321.24, 939.01, and 939.02 and to enact section 5709.30 of the Revised Code to require the Director of Agriculture to adopt rules establishing the Ohio Water Quality Improvement Program, to exempt land enrolled in the Program from taxation, and to reimburse local taxing units for revenue lost due to that exemption.

H. B. No. 608 - Representatives Grossman, Reineke.

To amend section 4511.204 and to enact section 4501.50 of the Revised Code to authorize a manufacturer of autonomous vehicles or autonomous technology to operate autonomous vehicles on public roads and highways in accordance with specified requirements, and to require the Director of Transportation to produce a report discussing whether additional legislative or regulatory actions are necessary for purposes of ensuring the safe testing of autonomous vehicles.

H. B. No. 609 - Representatives Antani, Duffey.

Cosponsors: Representatives Ramos, Brenner, Boggs, Dean.

To amend sections 3501.35 and 3599.20 of the Revised Code to allow electors to photograph and make public the elector's own marked ballot.

Said bills were considered the first time.
