The journal of the last legislative day was read and approved.

REPORTS OF REFERENCE AND BILLS FOR SECOND CONSIDERATION

Senator Faber reports for the standing committee on Rules and Reference, recommending that the following bill, standing in order for second consideration, be referred to committee as recommended:

Sub. H. B. No. 18 - Representatives Gonzales, Ginter, et al.

To amend sections 5301.072 and 5311.191 and to enact sections 4781.401 and 5321.131 of the Revised Code to prohibit manufactured homes park operators, condominium associations, neighborhood associations, and landlords from restricting the display of blue star banners, gold star banners, other service flags, and the POW/MIA flag, and to prohibit manufactured homes park operators and landlords from restricting the display of the United States flag.

To the Committee on State and Local Government.

H. B. No. 95 - Representative DeVitis, et al.

To amend sections 1753.07, 1753.09, 3901.21, 3963.01, 3963.02, and 3963.03 of the Revised Code to prohibit a health insurer from establishing a fee schedule for dental providers for services that are not covered by any contract or participating provider agreement between the health insurer and the dental provider.

To the Committee on Insurance.

Am. Sub. H. B. No. 103 - Representatives Pelanda, Kunze, et al.

To enact sections 5.2298, 125.66, and 125.67 of the Revised Code to designate the second week of March as Ohio Women's Week for Policy and Entrepreneurship, to create the Ohio Women's Policy and Entrepreneurship Committee, and to require the state, in collaboration with the private sector, to conduct a two-day competition and forum each even-numbered year during the designated week.

S. B. No. 177 - Senator Jordan.

To amend section 3798.04 and to enact sections 4731.74 and 4731.78 of the Revised Code to prohibit a physician from submitting patient medical records to an electronic database maintained by another party without patient authorization and from asking a patient about firearm ownership or possession.

To the Committee on Health and Human Services.

S. B. No. 178 - Senators Schiavoni, Gentile, et al.

To amend sections 2903.11 and 2929.14 and to enact section 2941.1424 of the Revised Code to impose a mandatory prison term of one, two, three, four, or five years on an offender who is convicted of or pleads guilty to a felony that includes, as an essential element, purposely causing or attempting to cause the death of or physical harm to another, if the indictment, count in the indictment, or information charging the offense specifies that the offense resulted in serious physical harm to a person who was less than 13 years of age.
