#### BE IT RESOLVED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

whereas, lyme disease is the most common tick-bothe lithess	4	
in the United States, with the Centers for Disease Control and	5	
Prevention (CDC) estimating that 300,000 Americans are diagnosed	6	
with the disease each year; and	7	
WHEREAS, Many cases of Lyme disease are never reported to	8	
the CDC, as only approximately 30,000 of the estimated 300,000	9	
cases of Lyme disease are reported to the CDC by state health	10	
departments each year; and		
WHEREAS, Lyme disease can cause devastating health	12	
consequences if left untreated, such as severe pain, heart	13	
palpitations, and chronic neurological damage; and	14

WHEREAS, Diagnosis of Lyme disease is difficult because	15	
there is no general consensus on the definition of its symptoms	16	
and the symptoms are similar to those of other conditions,	17	
leading to misdiagnoses. Furthermore, current Lyme disease	18	
testing methods often lead to inaccurate results; and	19	
WHEREAS, There remains much debate in the medical community	20	
concerning the proper courses of action for diagnosing and for	21	
treating Lyme disease; and	22	
WHEREAS, Greater knowledge of Lyme disease and its causes	23	
will put the general public in a better position to avoid	24	
contracting the disease; now therefore be it	25	
RESOLVED, That we, the members of the 131st General	26	
Assembly of the State of Ohio, in adopting this resolution, urge	27	
the CDC to take the following actions:	28	
(1) Update definitions of Lyme disease symptoms by clinical	29	
diagnosis;	30	
(2) Reconsider standards and best practices for diagnosing	31	
and for treating Lyme disease;	32	
(3) Provide more resources for health care professionals	33	
and the general public to learn about Lyme disease to aid in	34	
prevention, diagnosis, and treatment of the disease;	35	
(4) Improve the techniques that state and local public	36	
health agencies use to report cases of Lyme disease diagnoses so	37	
that fewer cases go unreported and the CDC can better monitor	38	
the incidence of the disease across the nation;	39	
(5) Provide the means for improved laboratory testing or	40	
funding for improved laboratory testing to enhance early	41	
detection of Lyme disease in humans; and be it further	42
