around him. An inventor and patent holder and the author of a	8
book, he was the owner and manager of several companies, chairman	9
of the board of The Hannon (Electric) Company, past president of	10
the Dougherty Wholesale Floral Company and Hannon International	11
Europa B.V., and vice president of Netherlands American Amity	12
Trust, and he was active with such organizations as Electrical	13
Apparatus Service Association International, the Nimishillen	14
Zoning Board of Appeals, the Ohio-area Foundation of Independent	15
Colleges, the Walsh University Board of Advisors, the Cleveland	16
State University Foundation Board, the Center for Strategic and	17
International Studies, the Ira Turpin Foundation, the William	18
McKinley Museum, the Hannon Early Childhood Center, the Carriage	19
Association of America, and the Carriage Museum of America, which	20
he founded. Also involved with the Stark County Republican Party,	21
he was the area coordinator for two presidential elections and an	22
at-large delegate to the Republican National Convention, and he	23
associated with dignitaries around the world as well as hosted	24
them in his home; and	25

life in our society was clearly evident in his personal sacrifices

of time and effort to his family, friends, and community. Giving
